6 **AN ORDINANCE AMENDING WEST JORDAN CITY CODE**  
7 **(FOR TITLE 17 ALCOHOL BEVERAGE CONTROL USES)**  
8

9 WHEREAS, the City of West Jordan (“City”) adopted West Jordan City Code (“City Code”) in  
10 2009; and the City Council of the City (“Council” or “City Council”) desires to amend and repeal certain  
11 Sections in Title 17 (Alcohol Beverage Control and Uses) (“proposed City Code amendments”); and  
12

13 WHEREAS, the Planning Commission of the City (“Planning Commission”) held a public hearing and  
14 provided a recommendation on \_\_\_\_\_, 2024, regarding the proposed City Code  
15 amendments; and

17 WHEREAS, the City Council held a work session (committee of the whole meeting) on September  
18 18, 2024, a public hearing on October 23, 2024, and a meeting on \_\_\_\_\_, 2024,  
19 regarding the proposed City Code amendments, and finds it to be in the best interest of the public health,  
20 safety, and welfare of the residents of the City to adopt the following proposed City Code amendments.

22 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF**  
23 **WEST JORDAN, UTAH, AS FOLLOWS:**

25 **Section 1.** Amendment of Code Provisions. City Code Title 17 is hereby amended as shown  
26 in Attachment A legislative version and Attachment B clean version to this Ordinance.  
27

28 **Section 2.** Severability. If any provision of this Ordinance is declared to be invalid by a  
29 court of competent jurisdiction, the remainder shall not be affected thereby.  
30

31 **Section 3.** Effective Date. This Ordinance shall become effect immediately upon posting or  
32 publication as provided as law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly  
33 overriding the veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the  
34 Ordinance within fifteen (15) days after the City Council presents the Ordinance to the Mayor.
