6 **A RESOLUTION SETTING THE 2025 PROPERTY TAX RATE**

7
8 WHEREAS, UTAH CODE ANN. Title 59-2-912 requires the governing body of any taxing entity to
9 set the real and personal property tax levy; and

10
11 WHEREAS, UTAH CODE ANN. Title 59-2-919(5) exempts the District from noticing and public
12 hearing requirements in order to propose a property tax rate other than the certified tax rate; and

13
14 WHEREAS, the Board approved Resolution No. 018 adopting the FY 2026 Tentative Budget with
15 the intent to exceed the certified tax rate; and

16
17 WHEREAS, the District Board has determined the requirements of the fund for which property
18 taxes are to be levied.

20 NOW, THEREFORE, BE IT RESOLVED BY THE FAIRWAY ESTATES SPECIAL SERVICE
21 RECREATION DISTRICT BOARD:

23 *Section 1.* For purposes of defraying the necessary and proper expenses of the Fairway Estates
24 Special Service Recreation District (the District) and for maintaining the administration thereof, it is hereby
25 determined that the property tax rate for the District to be placed upon all real and personal property within
26 the District made taxable by law in the year 2025 for the District's fiscal year ending June 30, 2026 is set
27 at a rate of .000909.

28
29 *Section 2.* The District, by and through the Board of the Fairway Estates Special Service
30 Recreation District, hereby expressly reserves the power and right to amend the foregoing tax rate as it may
31 deem just, proper, and appropriate under law.

33 *Section 3.* The Council Clerk shall submit a certified copy of this Resolution to the Salt Lake
34 County Auditor on or before June 30, 2025.

36 *Section 4.* This Resolution shall take effect immediately upon adoption.
