6 **AN ORDINANCE AMENDING THE 2009 WEST JORDAN CITY CODE**
7 **TITLE 2, CHAPTER 6, SECTION 2 (“PROPOSALS”) AND**
8 **SECTION 3 (“CRITERIA”)**

10 WHEREAS, the City of West Jordan (“City”) adopted West Jordan City Code (“City Code”)
11 in 2009; and

12 WHEREAS, the City Council of the City (“City Council”) desires to amend certain
13 sections of the City Code, regarding and related to the criteria required of third party charitable
14 or educational service entities to obtain a waiver of fees or in-kind support; and

15 WHEREAS, the City Council finds it to be in the best interest of the public health,
16 safety, and welfare of the residents of the City to adopt the following proposed City Code
17 amendments.

19 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF**
20 **WEST JORDAN, UTAH, AS FOLLOWS:**

22 **Section 1.** Amendment of Code Provisions. City Code Title 2, Chapter 6, Sections 2 and 3 are
23 hereby amended as shown in Exhibit A.

25 **Section 2.** Severability. If any section, part, or provision of this Ordinance is held invalid or
26 unenforceable by a court of competent jurisdiction, such invalidity or unenforceability
27 shall not affect any other portion of this Ordinance and all other sections, parts, and
28 provisions shall be severable.

30 **Section 3.** Effective Date. This Ordinance shall become effect immediately upon posting or
31 publication as provided as law and upon (i) the Mayor signing the Ordinance, (ii) the City
32 Council duly overriding the veto of the Mayor as provided by law, or (iii) the Mayor
33 failing to sign or veto the Ordinance within fifteen (15) days after the City Council
34 presents the Ordinance to the Mayor.
