3 **ORDINANCE NO. 23-06**

4 **AN ORDINANCE AMENDING THE 2009 WEST JORDAN CITY CODE, TITLE 6,**  
5 **CHAPTER 3 ANIMAL CONTROL, SECTION 6-3B-3 EXEMPTIONS TO**  
6 **LICENSING AND FEES; INCLUDING COMMUNITY CATS AND SECTION 6-3B-4**  
7 **LIMITATION ON LICENSES AND DOGS**

8 WHEREAS, the City of West Jordan (“City”) adopted the West Jordan City Code (“City Code”) in  
9 2009; and

10 WHEREAS, the City Council of the City (“City Council”) desires to amend certain sections of the  
11 City Code, regarding the City’s Community Cats Program and licensing of dogs and cats; and

12 WHEREAS, the City Council finds it to be in the best interest of the public health, safety, and welfare  
13 of the residents of the City to adopt the following City Code amendments.

14 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF**  
15 **WEST JORDAN, UTAH, AS FOLLOWS:**

16 **Section 1.** Amendment of Code Provisions. City Code Title, 6, Chapter 3, Sections 6-3B-3 and 6-3B-4  
17 are hereby amended as shown in Exhibit A.

18 **Section 2.** Severability. If any section, part, or provision of this Ordinance is held invalid or  
19 unenforceable by a court of competent jurisdiction, such invalidity or unenforceability shall not  
20 affect any other portion of this Ordinance and all other sections, parts, and provisions shall be  
21 severable.

22 **Section 3.** Effective Date. This Ordinance shall become effective after posting or publication as provided  
23 by law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly overriding the  
24 veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the Ordinance  
25 within fifteen (15) days after the City Council presents the Ordinance to the Mayor.
