6 **A RESOLUTION TO APPROVE A FEE WAIVER TO RENAME 1510 WEST**
7 **BETWEEN 8870 SOUTH AND 9130 SOUTH TO ELI MITCHELL WAY**

9 WHEREAS, Lisa and Jeremy Mitchell applied to rename 1510 West between 8870 South and
10 9130 South to Eli Mitchell Way in honor of their young son who lost his life near the intersection of
11 1510 West and 9000 South; and
12

13 WHEREAS, Lisa and Jeremy have requested a fee waiver in the amount of \$572 for fees
14 associated with the street rename request; and
15

16 WHEREAS, Utah State Code § 10-8-2(1)(a)(v) permits the City Council to waive fees and other
17 non-monetary assistance after first holding a public hearing; and
18

19 WHEREAS, West Jordan City Code 7-5-3(B) permits the City Council to waive fees associated
20 with a street name change request after holding a public hearing; and
21

22 WHEREAS, the City Council held a public hearing on November 1, 2023, to hear any public
23 comments regarding the waiver of fees for a street name change request.

25 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WEST**
26 **JORDAN, UTAH:**

28 SECTION 1. The City Council finds that the granting of a waiver for city fees associated with
29 this street name change request advances the goals, objectives, and purposes of the City and will
30 strengthen the community and provide for the health and welfare of the City's residents.

32 SECTION 2. The City Council approves Resolution 23-065 for a fee waiver request from
33 Jeremy and Lisa Mitchell for costs associated with renaming 1510 West between 8870 South and 9130
34 South to Eli Mitchell Way.

36 SECTION 3. This Resolution shall take effect immediately upon adoption.
