RESOLUTION NO. 23-066

**A RESOLUTION TO APPROVE A FEE WAIVER TO RENAME 8670 SOUTH
BETWEEN MILLRACE BEND RD (940 W) AND TERRA POINTE WY (1020 W)
TO JOSUA ELI WAY**

WHEREAS, Lisa and Jeremy Mitchell applied to rename 8760 South between Millrace Bend Rd (940 W) and Terra Pointe Wy (1020 W) to Joshua Eli Way in honor of their young son who lost his life near the intersection of 1510 West and 9000 South; and

WHEREAS, Lisa and Jeremy have requested a fee waiver in the amount of \$797 for fees associated with the street rename request; and

WHEREAS, Utah State Code § 10-8-2(1)(a)(v) permits the City Council to waive fees and other non-monetary assistance after first holding a public hearing; and

WHEREAS, West Jordan City Code 7-5-3(B) permits the City Council to waive fees associated with a street name change request after holding a public hearing; and

WHEREAS, the City Council held a public hearing on November 1, 2023, to hear any public comments regarding the waiver of fees for a street name change request.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WEST JORDAN, UTAH:

SECTION 1. The City Council finds that the granting of a waiver for fees associated with this street name change request advances the goals, objectives, and purposes of the City and will strengthen the community and provide for the health and welfare of the City's residents.

SECTION 2. The City Council approves Resolution 23-066 for a fee waiver request from Jeremy and Lisa Mitchell for costs associated with renaming 8760 South between Millrace Bend Rd (940 W) and Terra Pointe Wy (1020 W) to Joshua Eli Way.

SECTION 3. This Resolution shall take effect immediately upon adoption.
