3 **ORDINANCE NO. 23-39**

5 **AN ORDINANCE RENAMING 8760 SOUTH BETWEEN MILLRACE BEND**  
6 **RD (940 W) AND TERRA POINTE WAY (1020 W) TO JOSHUA ELI WAY**

7  
8 WHEREAS, the City has received a request from Lisa and Jeremy Mitchell to rename “8760 South”  
9 between 940 West and Terra Pointe Way to “Joshua Eli Way”; and

10 WHEREAS, the Mitchells feel replacing the name will honor their young son who lost his life near  
11 the intersection of 1510 West 9000 South; and

12 WHEREAS, the City Council held a public hearing on November 1, 2023 regarding the proposed  
13 street rename; and

14 WHEREAS, the City Council finds it to be in the best interest of the welfare of the residents of the  
15 City to adopt the proposed name change.

16 NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST  
17 JORDAN, UTAH AS FOLLOWS:

18 **Section 1. Street Name Change** – 8760 South between Millrace Bend Rd and Terra Pointe Wy shall  
19 be renamed “Joshua Eli Way” as proposed on the map provided in Attachment 1.

20 **Section 2. Severability**. If any provision of this Ordinance is declared to be invalid by a court of  
21 competent jurisdiction, the remainder shall not be affected thereby.

22 **Section 3. Effective Date**. This Ordinance shall become effective immediately upon posting or  
23 publication as provided by law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly  
24 overriding the veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the Ordinance  
25 within fifteen (15) days after the City Council presents the Ordinance to the Mayor.
