1. AGENDA SUBJECT

Ordinance No. 23-38 an ordinance renaming 1510 West between 8870 South and 9130 South to Eli Mitchell Way.

2. EXECUTIVE SUMMARY

Lisa and Jeremy Mitchell have applied to rename 1510 West in honor of their young son who lost his life near the intersection of 1510 West and 9000 South.

The renaming of this street would affect one property owner with a vacant strip of land, and two businesses located just south of 9000 South, Taylor Andrews Academy and the Armed Forces Career Center.

There is one existing sign (at Stone Meadow Dr) and one new sign (at 9130 S) that would need to be replaced/installed by the City. The signs at the intersection of 9000 South will need to be changed out by UDOT, as this is a signalized intersection. Currently 9000 South is under construction and is scheduled to be completed near the end of May/beginning of June 2024.

Salt Lake County Addressing has reviewed the proposed street name and has found the name to be free of duplication. Formal approval from West Jordan City Council approving the street name will need to be provided to Salt Lake County Recorder's office.

3. TIME SENSITIVITY / URGENCY

Coordination needed with UDOT for the replacement of the signs at 1510 West and 9000 South.

4. FISCAL NOTE

The number of signs to be updated would be a total of 5 signs, 3 City signs and 2 UDOT signs. According to the Consolidated Fee Schedule, the fee for the city signs would be \$347.00 plus \$75.00 times 3 signs, total cost would be \$572.00. ($\$347 + \75×3)

UDOT has offered to have the signs replaced by the contractor working on the 9000 South project, if the signs are replaced in conjunction with the intersection upgrades being completed around May/June 2024. If the family would like the signs replaced before the intersection upgrades are completed there would be an additional cost estimated to approximately \$300.00. The city council cannot waive fees imposed by agencies such as UDOT.

5. PLANNING COMMISSION RECOMMENDATION

6. STAFF ANALYSIS

Staff would recommend renaming 1510 West between 8870 South and 9130 South to Eli Mitchell Way. Staff would also recommend that the sign replacement at the intersection of 1510 West and 9000 South wait until construction of the intersection is completed. UDOT has agreed to replace the sign as a part of their project at no additional cost.

7. MOTION RECOMMENDED
