## 1. AGENDA SUBJECT

**Ordinance No. 23-39** an ordinance renaming 8760 South between Millrace Bend Rd (940 W) and Terra Pointe Wy (1020 W) to Joshua Eli Way.

## 2. EXECUTIVE SUMMARY

Lisa and Jeremy Mitchell have applied to rename 8760 South, the street on which they reside, to honor their young son who lost his life near 1510 West and 9000 South. The applicable city code can be found in WJCC 7-5-1 et. seq.

The renaming of this street would affect four property/homeowners. Each homeowner has signed the attached Petition associated with the Application for Street Name Change as noted in 7-5-2(A)(1)

Signs would need to be changed out at three intersections, Millrace Bend Way/Millrace View Cir, Duane Cv and Terra Point Wy. Each of the cross-street signs would need to be replaced to bring them up to current city sign standards, for a total of 6 signs.

Salt Lake County Addressing has reviewed the proposed street name and has found it to be free of duplication as required in 7-5-2(A)(2). Formal approval from West Jordan City Council approving the street name will need to be provided to the Salt Lake County Recorder's office. (7-5-2(A)(6))

## 3. TIME SENSITIVITY / URGENCY

There is no knowledge of any urgency.

## 4. FISCAL NOTE

The number of signs to be updated would be a total of 6 signs. According to the Application for Street Name Change the fee would be \$347.00 plus \$75.00 times 6 signs, total cost would be \$797.00. There are no anticipated third-party entity costs.
