1. AGENDA SUBJECT

Resolution No. 23-065 requesting a fee waiver in the amount of \$572.00 for costs associated with renaming 1510 West between 8870 South and 9130 South to Eli Mitchell Way

2. EXECUTIVE SUMMARY

Council is being asked to consider a fee waiver within the authority of the body. According to the Consolidated Fee Schedule, the cost of this street name change is \$347 plus the cost of the signs which is currently \$75/sign. Therefore, the total cost to replace the signs is \$572 (\$347.00 + \$225 (3 x \$75). The family is requesting a fee waiver in this amount.

Of note, the request would require 5 signs to be updated, 3 city signs, and 2 UDOT signs. The city council does not have the authority to waive fees imposed by outside agencies. It is estimated the cost for UDOT to replace the signs is approximately \$300 for the two signs that need to be updated on 9000 South. UDOT has offered to have the signs replaced by the contractor working on that project if signs are replaced in conjunction with the intersection upgrades being completed in May/June 2024. Those signs would not be replaced until that construction window opens.

4. FISCAL NOTE

The total fee waiver request is \$572.00 (\$347 + \$225 (3 x \$75). The Council has not exceeded the statutory limit of 1% of the budget in fee waivers this fiscal year.

UDOT's fee is expected to be approximately \$300 if the family chooses to have the signs changed prior to the installation by the contractor as part of the 9000 South project expected in May/June 2024. The council cannot waive UDOT fees. UDOT is willing to have the contractor install the new street signs as part of the 9000 South project early summer of 2024.

5. MOTION RECOMMENDED

Move to approve/deny **Resolution No. 23-065** a fee waiver in the amount of \$572 to rename 1510 West from 8870 South thru 9130 South to Eli Mitchell Way.

6. OTHER INFORMATION

The fee waiver request is associated with the renaming of 1510 West to Eli Mitchell Way. If the renaming ordinance does not pass, this item should not be considered. West Jordan City Code 2-6-1

et. seq. indicates the process the council shall use to consider all fee waivers. City code 7-5-3(B) provides the process to rename streets which provides the ability of the council to waive fees in this instance after a public hearing.
